# WHAT WE DO

The Bursar's Office, also known as Student Accounts, handles the charging and collection of various fees including tuition, housing, food plans, health insurance and other fees to the student account. We also apply financial aid and payments to the student account. Our office is focused on supporting students and families in resolving any outstanding balance with expertise and care.





#### **IMPORTANT DATES**

#### Mid-May

Students receive welcome email from our office to their Holy Cross email highlighting important dates, links, and processes.

#### Late June

Fall eBill released, notification sent to student's Holy Cross email.

#### August 1

Fall payment is due in full.

## August 1

Deadline for students to waive the Holy Cross Student Health Insurance Plan for the academic year if they have comparable, comprehensive health insurance that covers them while enrolled at Holy Cross.

# Late November

Spring eBill released, notification sent to student's Holy Cross email.

## January 1

Spring payment is due in full.



# **BILLING DETAILS**

- Billing is electronic and sent to student's Holy Cross email. Student can add authorized users so others can view the bill and make payments.
- Semester eBill is direct charges (tuition, fees, plus on-campus housing and food, if applicable) less any financial aid. Work study funds are not applied to the eBill. See next page for fees.
- ▶ TouchNet, our billing system, is different from STAR, which is used for financial aid & registration.
- ▶ Student access to TouchNet: Log into STAR, click the Billing/Bursar Office tile, then select "TouchNet Bill + Payment."

**To add an authorized user**, go to "Authorized Users" in TouchNet, and Click on "Add Authorized User."

## **WAYS TO PAY**

There are several payment options to manage the costs of a Holy Cross education. Some students and their authorized users select one or more of the options below. Reach out to us with questions — we are happy to help!

**Electronic Payment** – secure, fast and easy with immediate application to the student account

- ▶ ACH from checking or savings account use routing and account numbers, no fees
- Credit or debit card payment 3.0% convenience fee is applied, effective 5/1/2025

**Check or Money Order** – include student's full name and Holy Cross ID number on the front of each check and mail payment to:

**529 College Savings Plan Distributions** – Utilize the digital distribution option if your plan offers it. Be mindful of payment deadlines as distributions can take 7-10 business days. If your plan payment is sent by check, use our mailing instructions for checks above.

Payment Plans – Students or authorized users can enroll in a monthly payment plan to pay equal installments of the balance for the semester with scheduled, automatic payments in TouchNet. Enrollment fee is \$60 per semester, and no interest is charged. - Fall Enroll by 6/30 for 4-month plan, or enroll by 7/31 for 3-month plan
- Spring Enroll by 11/30 for 4-month plan, or enroll by 12/31 for 3-month plan
