

## **SUMMARY ANNUAL REPORT FOR HEALTH AND WELFARE BENEFITS PLAN**

This is a summary of the annual report of the HEALTH AND WELFARE BENEFITS PLAN (Employer Identification Number 04-2103558, Plan Number 506) for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

TRUSTEES OF THE COLLEGE OF THE HOLY CROSS has committed itself to pay all Dental claims, certain Medical claims, and Flexible Spending Account benefits incurred under the terms of the plan.

### **Insurance Information**

The plan has insurance contracts with Tufts Health Plan, Medicare Preferred, Fidelity Security Life Insurance Company, Fallon Community Health Plan Inc and Sun Life Assurance Company of Canada to pay certain Health, Prescription drug, HMO contract, PPO contract, Vision, Life insurance, Long-term disability, and Accidental Death & Dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$13,230,279.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. Financial information and information on payments to service providers.
2. Insurance information, including sales commissions paid by insurance carriers.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan: 1 College Street, Worcester, MA 01610, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
